# Nexxt Labs BV Refer-a-Friend Terms and Conditions

#### PLEASE READ THESE REFER-A-FRIEND PROGRAM TERMS AND CONDITIONS CAREFULLY.

This agreement ("Agreement") is between you (the "Referrer") and us ("Nexxt Labs BV"). By participating in our Refer-a-Friend program (the "Program"), you agree to be bound by these terms and conditions. If you do not agree to these terms, you may not participate in the Program.

#### 1. Program Overview

- 1.1. The Refer-a-Friend Program is designed to reward existing Apexx01 customers (the "Referrers") for referring new customers (the "Referred Friends") to Nexxt Labs BV.
- 1.2. Referrers can share their unique referral link and coupon code with friends to invite them to try Apexx01.
- 1.3. Referrers will earn 10% of the purchase amount for every automatic shipment made by their Referred Friends. This reward is only applicable on automatic shipments and not on one-time purchases.
- 1.4. Referrers can also provide a one-time 20% discount coupon to their friends for their first purchase of Apexx01.

# 2. Eligibility and Participation

- 2.1. Participation in the Refer-a-Friend Program is open to existing Apexx01 customers.
- 2.2. Referrers will automatically receive a personal referral link and a 20% discount coupon in their customer account.

#### 3. Referral Rewards

- 3.1. Referrers will receive 10% of the purchase amount for each Referred Friend who chooses the automatic shipment option, starting from the Referred Friend's second month onwards.
- 3.2. Referrers can accumulate rewards from up to 10 sales, at which point they will earn a complimentary Apexx01 shipment. Once 10 sales are achieved, the counter resets, and Referrers can start earning again.
- 3.3. If a Referred Friend pauses or cancels their automatic delivery, the corresponding 10% reward for the Referrer will be paused as well. If the Referred Friend reactivates their account, the Referrer will automatically be linked to them again, and the rewards will resume. However, if the Referred Friend has paused or canceled for more than 3 months and uses a different discount code when restarting, the Referrer will lose that Referred Friend.

#### 4. Discount Validity

- 4.1. The one-time 20% discount coupon provided by Referrers is valid only for the Referred Friend's first purchase of Apexx01, whether it is a one-time purchase or an automatic delivery purchase.
- 4.2. The 10% rewards for Referrers are valid as long as the Referred Friend's automatic delivery remains active.

### **5. Earning Potential**

- 5.1. Participation in the Refer-a-Friend Program allows Referrers to accumulate rewards towards earning a complimentary Apexx01 shipment.
- 5.2. There is no provision for earning monetary compensation through the Program.

## 6. Friend Activity

- 6.1. If a Referred Friend pauses or cancels their automatic delivery, the corresponding 10% reward for the Referrer will be revoked.
- 6.2. Reactivation of the Referred Friend's account will automatically reinstate the reward for the Referrer unless the Referred Friend uses a different discount code upon reactivation after a pause or cancellation lasting more than 3 months.
- 6.3. If the Referrer cancels their own automatic delivery, their rewards will be paused. Reactivating their delivery will restore their accumulated rewards and active Referred Friends.

## 7. Referral Discount Limit

Referrers can invite an unlimited number of friends and distribute an unlimited number of 20% discount coupon codes.

Nexxt Labs BV reserves the right to modify or terminate the Refer-a-Friend Program at any time without prior notice.
